Actions / Initiatives to Maintain or Let Go (Prevention Measures)

1 - Virtues Program students receive a certificate and recognition for demonstrating efforts with regards to the theme that has been selected will be maintained with some changes

2 - Additional supervision during recess and lunch to ensure a positive and safe climate will be maintained.

3 - Restorative Practice: for a supportive learning environment enables healthy relationships and promotes positive mental health and responsible behavior will be maintained.

4- Moozoom online program for social emotional learning support will be maintained.

5- School Wide Positive Behavior Plan -caught you being good tickets, monthly rewards will be maintained.

6 - Social Emotional Learning through The Zones of Regulation Program:

This curriculum is a cognitive behavioral approach that is aimed to be used to teach emotional awareness and self-regulation in a way that is cognitively accessible for the younger population. The goal of the Zones of Regulation's curriculum is to help students become more aware of and independent in controlling their emotions and impulses, recognize and assess the social situation and context through the expression's on others, manage their sensory needs, and improve their ability to problem solve through situations of conflict independently.
